I. Introduction

The new IPR regime established by the WTO TRIPS Agreement has generated immense interest among academic and industrial circles. The increasing significance of the subject has made it imperative to encourage the Under-graduate and Post-graduate students to acquire knowledge about it. With this view, this Short term Certificate Course on Intellectual Property Rights aims to help students understand the nature, scope and implications of patents, copyrights, trademarks and geographical indications.

IV. Course Details
